### Special Election

#### 1% Sales Tax for Education (Vote for One)

Shall a special one percent sales and use tax be imposed in Carroll County for a period of time not to exceed five years (20 calendar quarters) commencing upon the expiration of the existing one percent sales and use tax currently in force, and for the raising of not more than \$333,000,000, to be divided, \$240,026,400 (72.08%) to the Carroll County School District, \$86,313,600 (25.92%) to the Carrollton Independent School System, and \$6,660,000 (2.00%) to the Bremen Public School System, for the purpose of providing funds to pay or to be applied toward the cost of the following:

(A) for the Carroll County School District (the "County School District"): capital outlay projects within the Carroll County School District in a maximum amount of \$240,026,400 to pay the costs, but not limited to (a) classroom additions, modifications, renovations and improvements to Bowdon Elementary School, Central High School, Central Middle School, Mt. Zion High School, Providence Elementary School, Temple Elementary School, Temple Middle School, Temple High School, Glanton Hindsman Elementary School, Ithica Elementary School, Villa Rica Elementary School, Villa Rica High School, and (b) system-wide property or land acquisition and renovation of existing schools and facilities; construction of new schools and facilities; system-wide athletic facilities; additions, renovations, modification and improvements to facilities; parking lots and driveways; replacing, purchasing, upgrading, or supplementing capital equipment to include, but not limited to, school buses, tractors, trucks, furnishings, technology, laboratory, physical education, athletics, band, fine arts, safety, security, or other equipment and furniture; books and other instructional equipment, and energy efficiency upgrades (the "County School Projects");

(B) for the City of Carrollton Independent School System (the "Carrollton School District"): payment of a portion of the debt service for the CARROLLTON INDEPENDENT SCHOOL SYSTEM GENERAL OBLIGATION BONDS, SERIES 2015 in an amount not to exceed \$13,864,000 (the "Carrollton Previously Incurred Debt"); and capital outlay projects within the Carrollton School District, in a maximum amount equal to \$72,449,600 or such amount of the net proceeds to be raised by the tax for the Carrollton School District after provision for the payment of Carrollton Previously Incurred Debt, consisting of acquiring, constructing, adding to, renovating, modifying, repairing, improving and equipping existing schools and other buildings and facilities, and acquiring any property necessary or desirable therefor, both real and personal, including but not limited to, the following and without prioritizing any of such items: (a) a new early learning center to house PreK and kindergarten students; and (b) classroom additions; HVAC additions and modifications; roof replacement and repair; interior and exterior painting; flooring replacement and repair; replacing, purchasing, upgrading, or supplementing capital equipment to include, but not be limited to, school buses, tractors, trucks, furnishings, technology, laboratory, band, fine arts, safety, security, physical education, athletic, or other equipment; books and other instructional equipment; system-wide athletic fields; energy efficiency upgrades and acquisition of energy savings project equipment currently being leased; parking lots and driveways; acquisition of land and construction of new schools or facilities as needed (collectively, the "Carrollton School Projects"); and

(C) for the Bremen Public School System: a portion of the debt service for the CITY OF BREMEN SCHOOL DISTRICT GENERAL OBLIGATION BONDS, SERIES 2021, in a maximum amount equal to \$6,660,000?

If imposition and continuance of the tax is approved by the voters within the Carroll County School District, such vote shall also constitute approval of the issuance of general obligation debt of the Carroll County School District in the maximum aggregate principal amount of \$51,000,000 for the County School Projects.

If imposition and continuance of the tax is approved by the voters within the Carrollton School District, such vote shall also constitute approval of the issuance of general obligation debt of the Carrollton School District in the maximum aggregate principal amount of \$50,000,000 for the Carrollton School Projects.
